Proposed revisions to Sunnyvale Massage
Municipal Code 5.36 (Taxicabs)

Revision Highlights

- ❖ Minimum driver requirement eliminated
- ❖ Driver permits – extended from 1 to 2 years
- ❖ Minimum vehicle requirement will continue to be five (5) vehicles per franchise
- ❖ Driver uniform requirement removed
- ❖ Drivers can use a mobile phone or electronic app to stay in contact with dispatchers
- ❖ Drivers can keep their daily trip manifest in electronic format

Revision Highlights

Changes to Franchise Application:

- ❖ City Council can award a franchise for two (2) years, plus two (2) two-year extensions approved by the Director of Public Safety
- ❖ Total term will be six (6) years: franchise fee covers the entire six-year period.
- ❖ Franchise must be in good standing to be awarded extensions.
- ❖ Extension application and process for submission will be similar to current franchise application process.
