



RESOLUTION NO.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SUNNYVALE ADOPTING THE 2015 URBAN WATER MANAGEMENT PLAN TO BE SUBMITTED TO THE CALIFORNIA DEPARTMENT OF RESOURCES

WHEREAS, the California Legislature has enacted the Urban Water Management Planning Act, California Water Code Sections 10610-10656, as amended, which requires every urban water supplier providing water to more than 3,000 customers or supplying more than 3,000 acre-feet of water annually to prepare an Urban Water Management Plan ("Plan") that has as its primary objective the conservation and efficient use of water; and

WHEREAS, the City of Sunnyvale ("City"), a municipal utility and chartered city, is an urban water supplier providing water to a population over 148,000; and

WHEREAS, the City adopted a Plan in 2010 in accordance with State requirements; and

WHEREAS, the Plan must be reviewed at least once every five years by the City, which must amend the Plan, as necessary, after it has conducted a review; and

WHEREAS, the preparation of the updated Plan has been coordinated with other public agencies to the extent practicable; and

WHEREAS, the Plan must be adopted by July 1, 2016, after it is first made available for public inspection and a public hearing is noticed and held, and it must be filed with the California Department of Water Resources within thirty days of adoption; and

WHEREAS, after reviewing a draft Plan at their May 23, 2016 meeting, the Planning Commission that the Council adopt the Plan as presented; and

WHEREAS, a noticed public hearing on the revised draft Plan was held by the City Council on June 21, 2016, at which time public comments were heard and considered.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SUNNYVALE THAT:

SECTION 1. The Council hereby adopts the 2015 Urban Water Management Plan of the City of Sunnyvale, which shall be filed with the City Clerk. The City Manager is hereby authorized and directed to file the 2015 Urban Water Management Plan of the City of Sunnyvale with the California Department of Water Resources and the State Library.

SECTION 2. The Council finds and determines that, Under California Water Code Section 10652, the adoption of the Plan and this Resolution does not constitute a project under the California Environmental Quality Act, and no environmental assessment is required.
