Vice Mayor Larsson proposed a study issue regarding changing policy to allow street furniture in front of businesses on Murphy Avenue to be left out overnight or taken in only for the street cleaner, in order to allow better, high quality street furniture to be purchased and create a higher quality environment.

Councilmember Griffith co-sponsored the study issue.

Councilmember Martin-Milius spoke in support of the City going to 100% clean energy with Silicon Valley Clean Energy.

City Manager Santana stated staff is looking to bring an item to Council in December for consideration.

Councilmember Martin-Milius spoke in support of electrifying water heaters and HVAC to reduce greenhouse gases, and to smooth out permitting for them.

City Manager Santana stated the issue is an item for the policy priorities session on January 27.

Councilmember Martin-Milius proposed a study issue to look at a general policy issue regarding the shadowing of antennas.

Councilmember Griffith echoed Councilmember Martin-Milius' comments regarding electrification.

Councilmember Griffith reported San Jose approved a \$15 minimum wage by 2019 and suggested revisiting the City's ordinance to align with the other cities in the region.

City Manager Santana stated she will bring an item back to Council for discussion at the appropriate time.
