Study Session Purpose

Review the application of Proposition 64 and Local City Regulations on Medical Marijuana and Smoking to determine gaps in regulation.

Provide input and direction to staff to develop scope of regulation for adult use of marijuana.

Review of Existing Law & Ordinances

Prop. 64- Adult Use of Marijuana Act

Key provisions:

- Recreational use of marijuana legal over age 21
- Cultivation of 6 plants per residence legal for personal use; reasonable local regulation of cultivation allowed
- State regulatory and licensing system for commercial cultivation, testing, processing
- Local government may prohibit OR regulate/license commercial nonmedical marijuana activities
- State taxes on purchase of Non-Medical Marijuana
- Option to impose local tax

Sunnyvale

Medical Marijuana Regulations

- Personal cultivation prohibited
- Commercial cultivation prohibited
- Delivery prohibited
- **Recommended Policy Action:**
Amendment to permit and regulate cultivation of up to 6 plants for personal use.

Sunnyvale Smoking Ordinance & Regulations

- Smoking prohibited in areas set by state or federal law and various additional locations:
 - Elevators
 - Outdoor dining areas
 - Gymnasiums, fieldhouses, stadiums and outdoor theaters
 - Public parks
 - In service areas
 - Public places, when being used for a public event
 - In the pedestrian retail district
 - Multi-family housing
 - Prohibition applies to smoking marijuana; Prop. 64 also prohibits smoking marijuana in public places

Staff Recommendation: No additional action required, maintain status quo.

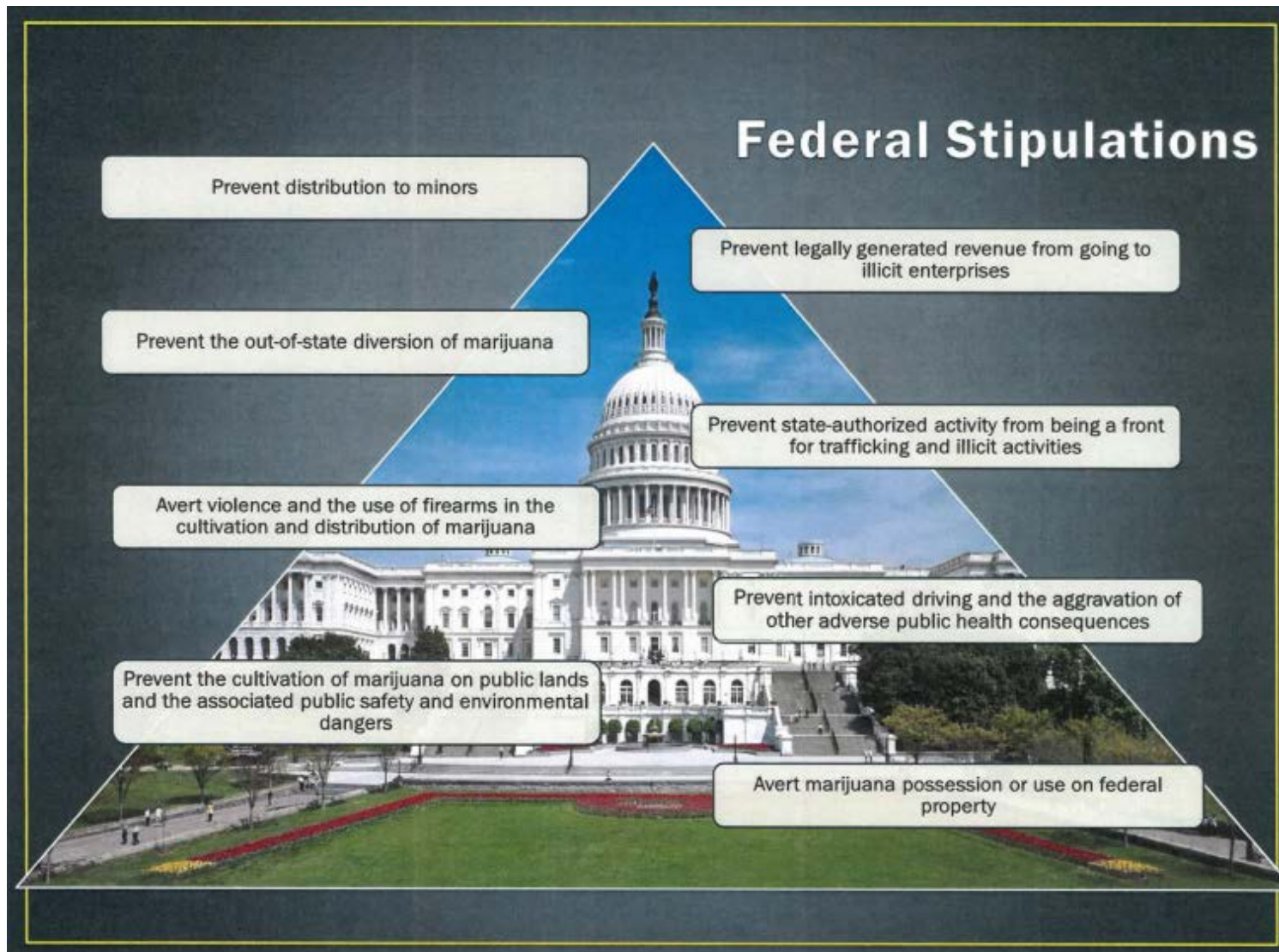

Regulation & Enforcement Issues

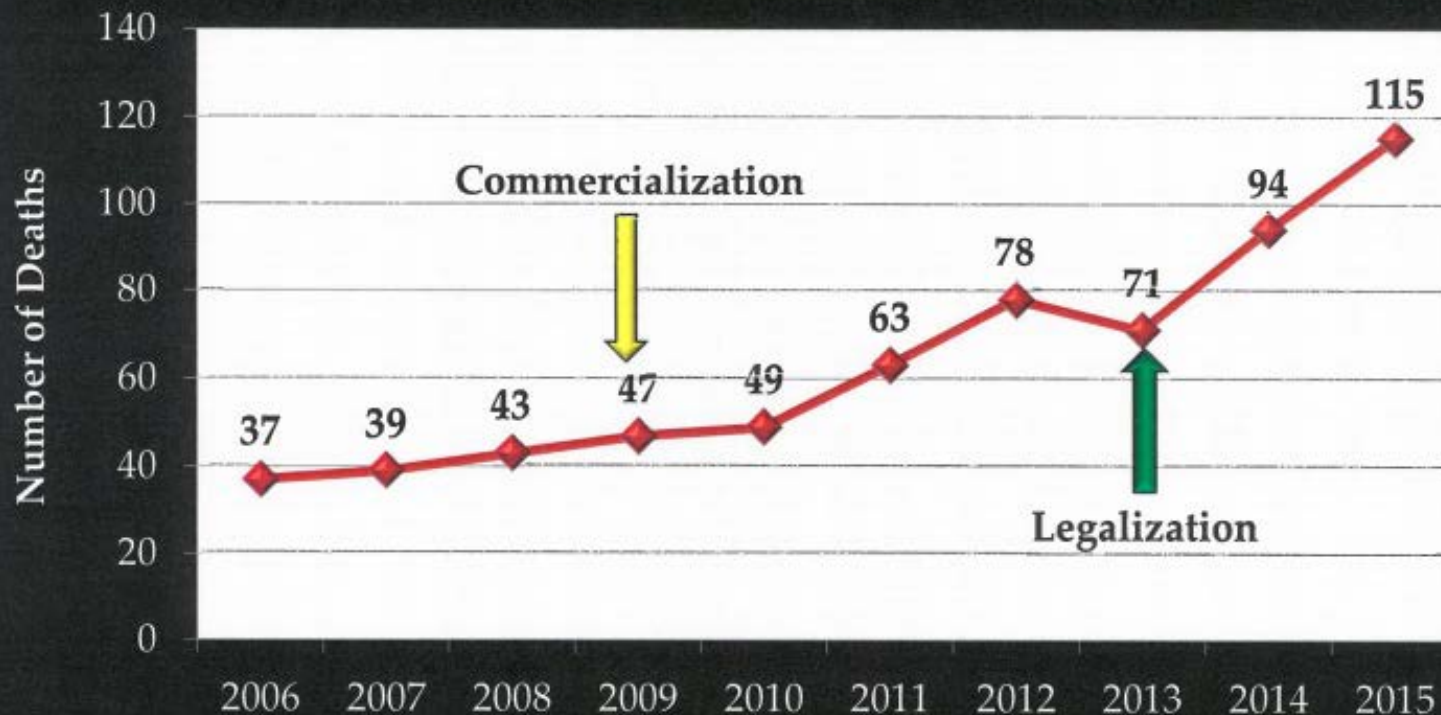
- Data and trend information from Colorado and Washington relative to adult use of marijuana and regulations supports local concerns related to marijuana:

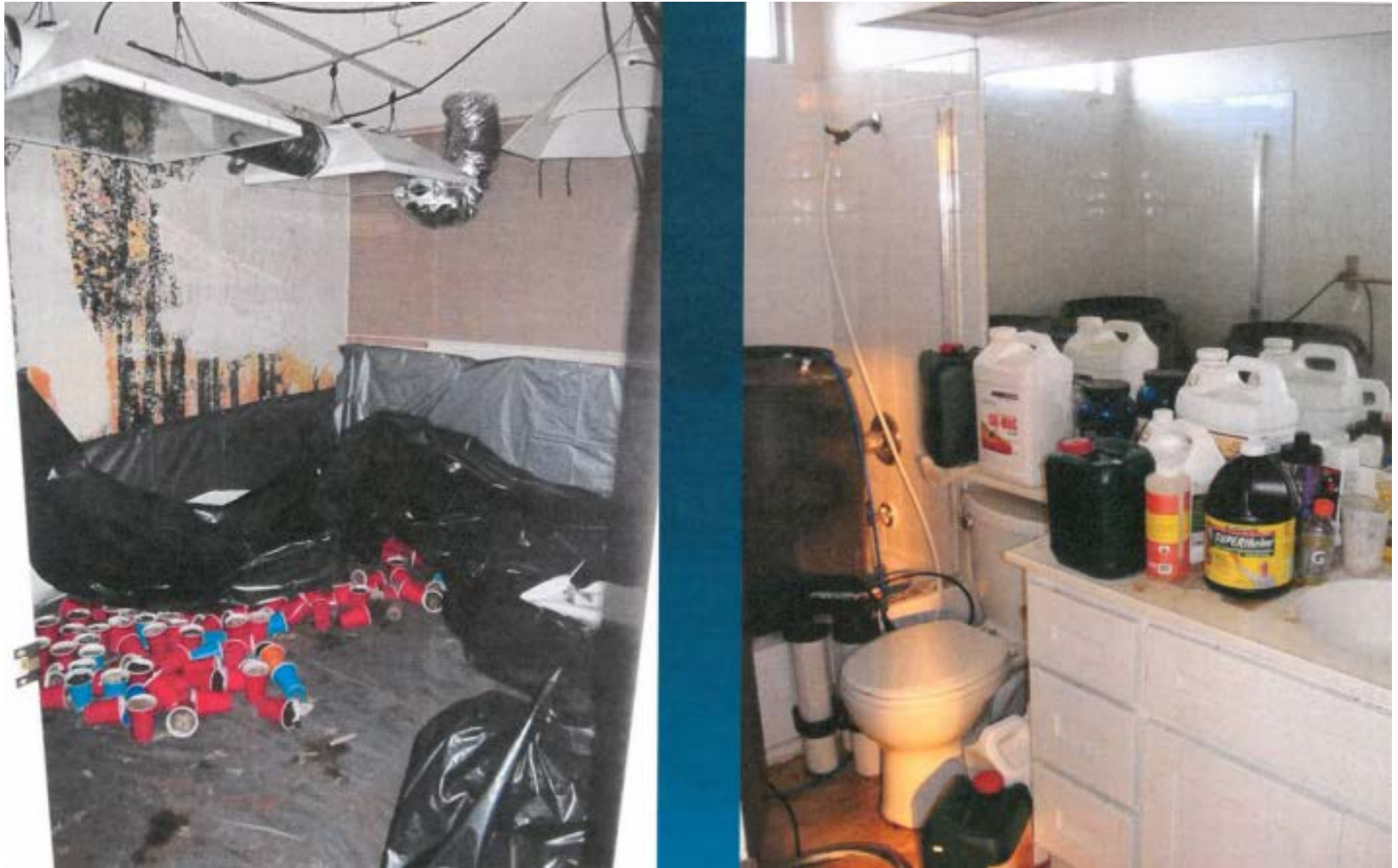
Public Health & Safety Concerns

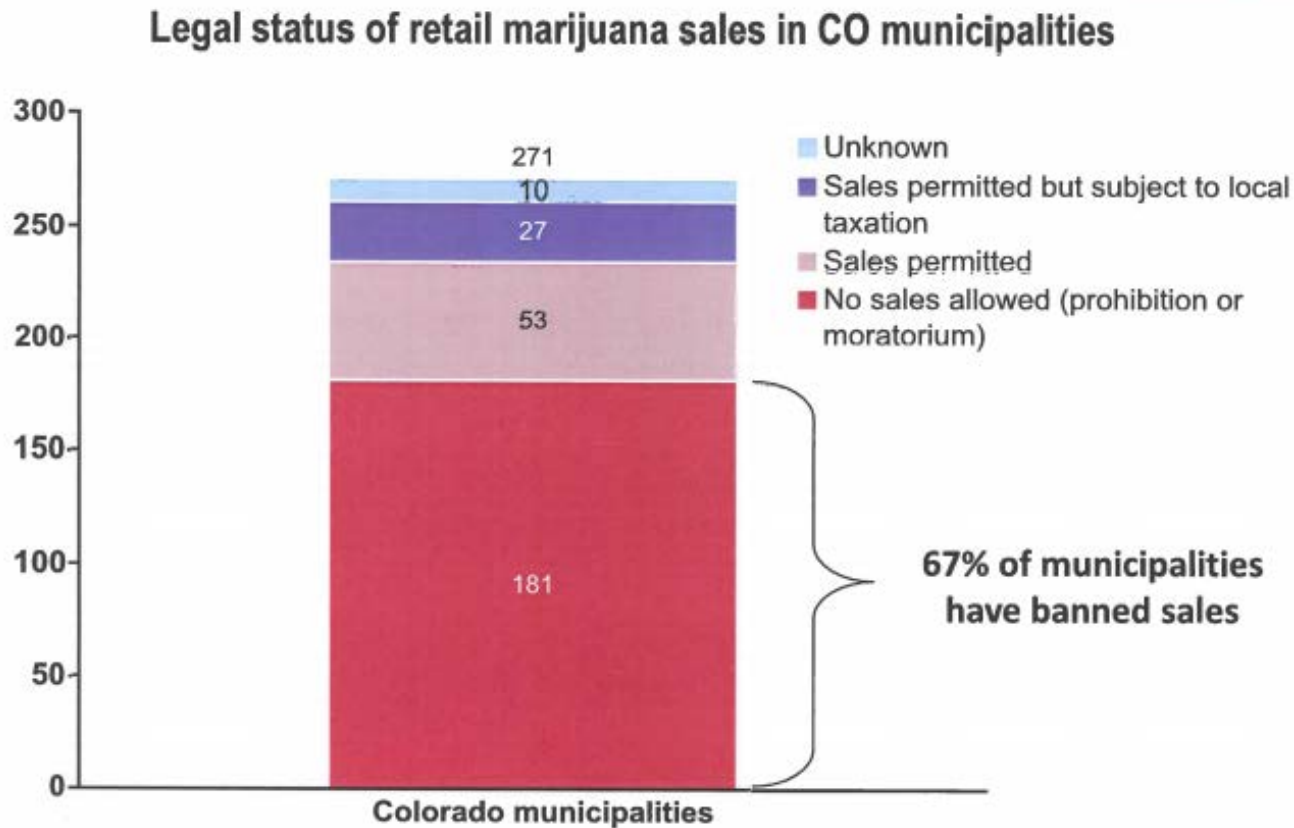

Next Steps

- Return to Council in Q1 with update to marijuana ordinance for consistency with Prop. 64
 - Personal cultivation of 6 plants allowed, subject to local license/regulation for public health, safety and welfare
 - Maintain other existing prohibitions on commercial cultivation, delivery, manufacture, other activities
 - Advance for Council consideration the proposed study issue on regulation of marijuana for research purposes to include public input, allow staff to understand the required state process and implications
