Dear Planning Commission-

Re: 615 N. Mathilda Ave., Loss of TV Reception

It has come to my attention that my brief presentation at your November 7th Study Session was misinterpreted. Apparently someone thinks, "Jim Quaderer had a solution to the TV reception issue." This statement is misleading.

While it IS true that I was able to fix my TV reception issue caused by 505-555 the N. Mathilda office buildings by moving my TV antenna, I do NOT have a technical solution for my signal becoming completely blocked after construction at 615 N. Mathilda is underway. My signal will be completely blocked this time. I expect to completely lose my TV reception and there will be nothing I can do about it. I have no technical solution.

I am presently working on a proposal regarding compensation for residents who have lost TV reception due to blockage by a tall building. I ask that you delay the approval of the 615 N. Mathilda Ave. until we can get an agreement in place.

I live in SNAIL and also use OTA (over the air) TV channels instead of expensive cable or satellite service for some of my entertainment choices. The OTA channels are higher quality than most SD (standard definition) digital signals available from cable or satellite TV providers. It cost much more than the basic cable TV service to get HD channels like those available OTA for free.

Please do not approve any more tall buildings along N. Mathilda Ave until the city council develops a policy to compensate residents who lose access to free OTA TV channels to benefit nearby property developers.
