NOW, THEREFORE, THE PARTIES ENTER INTO THIS SECOND AMENDMENT TO TEMPORARY PERSONNEL SERVICES AGREEMENT:

4. Compensation

Replace the first paragraph of this section with the following:

CITY agrees to pay AGENCY at the rates set forth in Exhibit "B", Fee Schedule, attached and incorporated by reference. Total compensation shall not exceed One Hundred Fifty-Five Thousand and No/100 Dollars (\$155,000.00).

All other terms and conditions remain unchanged.
