Assistant Director of Public Works, Craig Mobeck, presented the staff report on Animal Assisted Happiness at Baylands Park that provides vocational activities where young adults can learn to care for animals, including feeding and cleaning stalls.

Commissioners inquired about parking related costs, City subsidies and flood safety in the proposed location of the facility.

Assistant Director of Public Works Mobeck responded that all visitors will pay for parking and the City will not receive payments from the organization or subsidize the facility. The proposed location is not in a flood zone.

Vicki Amon-Higa, co-founder of Animal Assisted Happiness, discussed the benefits the organization provides to families and children with special needs.
