I operate a Small Family Daycare (up to 8 children) at 1220 Vienna Drive, spc 546, Sunnyvale, CA, 94089 (Plaza Del Rey Mobile Home Park). I would like to expand the daycare up to 12 children. My Mozaica Preschool and Daycare provides services for working parents who want their children to stay in loving and home-like setting that also provides high quality educational programs for kids. I have a 6 year experience of working in home-based daycare and more than 1 year in a day care center. I also worked as a middle school teacher for more than 15 years. It was my great dream to open my own preschool and daycare and offer the best service. I am very fond of children and love my job. The children from all backgrounds are welcomed. As my native languages are Ukrainian and Russian, I already have lot of requests from the Ukrainian or Russian Speaking parents, who work in high-tech industries nearby. There are some English-speaking parents who want a Russian Immersion school for their kids.

I am always careful not to disturb our neighbors and be respectful towards them. The daycare working hours are from 8 am to 6 pm. Nevertheless, the parents will come at different times, so it won't disturb the neighbors. Also most of them are working during this period. I always have one parking lot on my own driveway and there are 10 guest parking lots at distance from five spaces from me. There are more than 16 guest parking lots nearby as well. I require parents not to park on the Plaza Del Rey Park driveways.

The outside activities time for kids is from 10.30 am to 12.00 pm and from 4.30 pm to 5.30 pm. I am sure that adding 4 more children will not interfere with the noise level in the neighborhood, especially since they will play in the backyard which is adjacent to Lawrence Expressway.

I am planning to hire one more person or it can be my mom, who lives with me. If I am granted a use permit, this will allow me more flexibility and capability of serving more families, some of which may be my immediate neighbors.

- **Parking on the street and next to the resident's driveways is strictly prohibited!


 Violation of the parking policy may result the termination of the contract.






Play structures are less than 8 feet in heigh and will not require a separate Planning permit.






The dinning and living rooms are connected. This space is for sircle time, reading, play, lunch and nap time.

There are 26 givest parking spaces nearby. Five of them





I am planning to enroll up to 12 children. 4 children will attend the daycare 5 days per week (full time). 4 kids will attend the daycare 5 days per week, but half of the day (part time), 4 kids fill attend the daycare 2 to 3 days per week (part time).

Overall it will be 4 full time children and 8 part time children.

If I decide to hire one more teacher, I will allow her/him to park her/his vehicle on my own parking space near the house. There are two parking spaces and one of them is always available from 8 am to 7 pm because at that time during the weekdays my husband is out of the home.
