A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SUNNYVALE FIXING THE DAYS AND TIME FOR REGULAR CITY COUNCIL MEETINGS FOR 2018

WHEREAS, Section 608 of the Sunnyvale City Charter provides that the City Council shall hold regular meetings at least two times a month, and further provides that the times for such shall be fixed by ordinance or resolution; and

WHEREAS, on November 16, 2004, in order to change the start time of council meetings, so as to encourage more public input and participation, the City Council adopted Resolution No. 141-04 which provides that regular monthly meetings of the Council shall be held at least two Tuesdays each month at 7:00 p.m. in the City Council Chambers, Sunnyvale, California, or at other locations to which the Council may adjourn within the City; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SUNNYVALE THAT the regular City Council meetings shall be held starting at 7:00 p.m., in the City Council Chambers, Sunnyvale, California, on the dates specified in Exhibit A of this Resolution, for the meetings occurring in 2018 and through February 2019.
