Hi Mary,

We filed an appeal on Friday 1/23/18 regarding the Verizon equipment at our front door at 214 Commercial Street. What are the next steps?

Can I still come in a talk with you or a member of the Public Works to help me understand our easement and see if the other pole on our side property may be an alternative for your consideration in case the facade or roof top or existing cell towers at the Corp Yard continue to be ruled completely out?

I have a description of the easement (dated 1/12/1973) but I can't find it on the map that I have (dated 8/1/1952) or the assessors map.

I'm still hoping the City can look at your yard as a solution. I know that Verizon says your cell towers are too far away from our pole, but according to William Hammett, the expert I met through you, Verizon's equipment has a 4-block reach. I hope Verizon could give it a try first at the existing tower and prove to you it won't work. This would keep the aesthetic intact.

Also, I want you to know I spoke to PG&E representative on Friday, 1/23, at the Building and Renovation Department. Per the supervisor through the phone rep I was talking to, I was told that they have *no information* regarding the Verizon pole extension and that *nobody* can go above the crossbar on our pole for any reason, that that space above the crossbar is PG&E property. This is in stark contrast to what I was told by Dan Gilardoni, PG&E Communications (I believe?) who told me that Verizon has been doing this for the past 5 years. I see on the Verizon plans, Verizon will relocate the communication bar on the pole...doesn't that need to be known by the Building and Renovation Department of PG&E?

Also, if the City will still approve the plan despite our appeal, how does the progress work? Per the plans, it is indicated that we must give up our parking spaces for 72 hrs in advance. Is this the norm for businesses in a NO Parking zone? Our side streets are already full of parked cars. Where do they suggest our employees park? How many days will the work take? Do they work at night or on weekends? Will they need to shut off power, phone & cable at any point? Do they compensate companies like mine if I will have to pay an outside IT company to reset our network? From your experience what other kinds of disruption to our business may happen?

Once again, thank you for your help and patience with Seville. We are the owners of this property and our small company and we are doing the best we can here.

Hi Mary,

Yes, I understand Verizon wants our pole and is within their right to ask for your permit to use it.

Yes, I recall you asked Verizon to consider the existing cell towers (it threw me off when Marjorie said they can't by law use them...) and you forwarded me Verizon's response. (Please see the attached file Alternate Site Analysis) They did not analyze and rule out the existing cell towers you asked them to review. They ruled out light poles on the City property only. In fact, in their photo, the existing cell towers on the CorpYard are photoshopped out of their analysis!

Nor did they report on facade or roof top alternatives per the City's Visual Criteria.

To repeat Verizon:

Verizon would like to remain on the proposed pole, as proposed in our application, as we have sited in a commercial/industrial district location where there are tall trees that help screen the view of the equipment. We found this location is ideal for siting utility as such in the Public Utility ROW. In Verizon's Site Analysis, please refer to page 5, a misleading visual simulation of our pole. The trees represented in this image are either across the street at the Corpyard or are photoshopped into the image of our pole. And there appears to be only 1 PG&E canister when there are 2 large existing canisters and the proposed bollards do not appear at all. The bollards & caution signs should have been included in their representation since it may impact our compliance on parking and worker safety at our building at city, state & federal levels.

The only general reference to the existing towers in the Alternate Site Analysis is this:

• Existing antenna towers, monopoles, and rooftops located more than 150 feet from the proposed location are not viable alternatives for the small cell network because they do not meet Radio Frequency Coverage requirements, i.e., network objectives

What Verizon can do is choose from more than 800 models of Amphenol antennas for the Corpyard existing towers.

I learned this when I compared the model Verizon specified for analysis for the 665 Carlilse Way application, Amphenol CUUT360x12Fxyz, and the unspecified Amphenol model shown in our blueprints. These appear to be different models, different weights as our antenna model is to be 53 lbs and the Carlisle model is only 38.1 lbs. This of course causes concerns for me personally but also gives me hope that a different antenna may work across the street. I can show you on our plans and for more information you can go to: amphenol-antennas.com/product-category/small-cell/outdoor-antennas/

In my email to you on February 26, I wrote:

Mary, I know Verizon has the right to ask for our pole but I'm asking for a better solution. I am so truly grateful you are taking a close look at this and agreeing to meet me here!

You have my response (email sent to you on Feb 8, 2018) regarding the poles in the City's Corp yard. I have attached an image where the City circled the Corp yard poles for Verizon and City's comments to Verizon recommending corp yard poles. See below for the response we received from Verizon in blue text. I have also attached the reservation of rights (legal brief – referred in their response) in my Feb 8 email to you.

We are replying back concerning the poles you have circled in the attached photo appear to be on private and/or city property.

Verizon is proposing to install their equipment on existing wooden utility pole that is in the Public ROW. Verizon has rights to locate on these pole as Public Utility, see legal brief attached and below is an excerpt of their rights:

Among other Federal and State Rights, California Public Utilities Code § 7901 grants a statewide franchise to telephone corporations such as Verizon Wireless to place telephone equipment in the public rights-of-way, and the use of the rights-of-way by telephone corporations is a matter of statewide concern that is not subject to local regulation except where such use incommodes the public use of a road or highway

We found this location is ideal for siting utility as such in the Public Utility ROW.


