A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SUNNYVALE APPROVING THE LIST OF PUBLICLY ACCESSIBLE RECREATION AND CITY SERVICES PROPERTIES SUBJECT TO THE REQUIREMENTS OF SUNNYVALE MUNICIPAL CODE CHAPTER 2.07

WHEREAS, in November 2016, a citizen initiative (Measure M) that would have required voter approval for any that any sale, lease, lease extension, lease renewal, land swap or transfer of property owned, leased or used by the City as a public park or community service amenity failed by a very small margin; and

WHEREAS, to respond to some of the concerns raised by the community as part of Measure M, including preserving public parks, open spaces, and community amenities for public use, public perception that the City is under increasing pressure to repurpose public lands, and that checks on such pressures are necessary, on or about June 26, 2018, the Sunnyvale City Council voted to amend *[OR submit amendments for voter approval in the November 2018 election]* certain sections of Sunnyvale Municipal Code Chapter 2.07 relating to Purchase, Sale or Lease of Real Property to provide special approval requirements for properties designated as “Publicly Accessible Recreation and City Services” (PARCS) properties; and

WHEREAS, the amended provisions of SMC Chapter require that the Council adopt by resolution a list of PARCS properties subject to the new provisions of Chapter 2.07.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SUNNYVALE THAT:

1. The City Council hereby approves the list of PARCS properties attached to this Resolution as Exhibit “A.”
2. The effective date of this resolution shall be the effective date of the ordinance *[OR the effective date of the ordinance amending Chapter 2.07 if adopted by a majority of voters in the November 6, 2018 election. If the ordinance is not adopted by the voters, this resolution shall not go into effect.]*
