neighborhoods.

Richard Mehlinger urged the Council to deny the appeal and allow the project to move forward.

Steve Scandalis spoke in support of the appellant's objections to the project.

Zachary Kaufman spoke about aggregating single family homes.

Appellant Maria Hamilton provided additional comments in support of the appeal, and shared her alternatives for the project which consist of eight smaller units with two bedrooms and a one-car garage, with one unit being designated as affordable housing.

Applicant Jeff Guinta stated that housing and planning is different today than it was in the past and provided comments regarding the number of bedrooms and parking suggested by the appellant.
