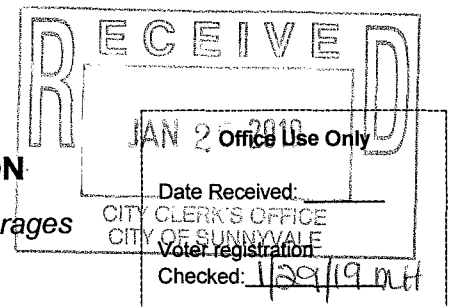



However, the library is more than a repository for resources. It also serves as an important focal point for the community to gather and to feel like they are part of a larger community. Expanding programs, talks and resources that encourage residents to physically visit the library are important to continuing the tradition of the library as a gathering place for patrons, young and old.




