  - Do we have licensed breeders in Sunnyvale?
- Is there a requirement for appropriate keeping of garbage to deter wildlife?
  - Would this apply to gardens (to prevent nuisance wildlife in the area/does it count as "feeding"?)
- Does a bite require broken skin to be reported?
- Are dog parks restricted to S/N dogs?
  - Why/why not?

- Can there be off-leash hours at parks & schools?
- Thank you for addressing nuisances in a broadened manner in proposed updates
- Better enforcement of nuisances
- What is the process for enforcement for a "noisy animal"?
  - What is the definition?
  - Is there a time of day limit (i.e. only applies at certain times, like other noise ordinances)?
- 2 hour time limit for found animals is that how long AC has to pick up animals? Or is for reporting?
- What is the age for a senior fee waiver?
- Are roosters prohibited?
- Distance requirement for small animals is distance to lot/yard or to structure?
- What is included in livestock prohibition?
- Are there restrictions on reptiles/fish/arachnids?
- Is there a grandfathered-in exception for keeping livestock?
- Are there codes about animal fighting?
- By requiring vets to provide rabies notification, there is a "big brother" concern about providing private information to the City.
- Why did we switch to PetData? How much do we pay PetData?
- What can the City do about crows/nuisance wildlife?
- Including parrots as noisy animals, does that apply to the wild ones as well?
- Are we increasing fees (licensing)?
- How about a lifetime license/one time license fee?
- Host an annual event to vaccinate & license in one
  - o Include information about why people should want to license and where the money goes

- Are public safety officers trained in basic animal handling? I ask because I hear of police shooting dogs unnecessarily. Also do you call a wildlife organization when dealing with wild animals? I say this because some years ago an opossum was violently bludgeoned to death by a police officer who was obviously afraid of the animal. Even the woman who called animal control was disgusted at the violence.
  Opossums are benign animals and would rather run when threatened. I hope things have improved with wild animal interactions. Thank you.

- There should not be a max limit
  - It should not apply to dogs/cats at residences temporarily, only permanently
  - Can wording of limit reflect pets that reside and exclude "visiting" animals?
- There should be a permit requirement to breed
  - Permit should require litters won't be given to shelters or rescues
- Requirement for vets to provide rabies notification is a burden
  - Vets should be solicited for feedback
- Can there be an exception to animal limit for fostering? Or a permit to allow it?
- Are there permits or regulations for pet sitters who use apps/websites?
- What are the conditions to impound an animal and the process to do so?
