On April 12, 2018 I was asked by Fraranak Pourghasemi to inspect the site at 1005 E Homestead Avenue in Sunnyvale and give recommendations on the preservation or removal of the trees at this location in consideration of the upcoming construction project.

Below are my observations and recommendations (please see attached photos and site map to assist with location and identification):

A. Tree Species: Bay Circumference: 208" Recommendation: Remove Botanical Name: Laurus Nobilis Health: Poor

Tree A – This large Bay tree has been topped in the past causing large columns of decay in the main scaffolding branches and the main trunk is hollow from large old wounds. This tree is an extreme hazard and should be removed. (See attached photos)

B. Tree Species: Deodor Cedar Circumference: 90" Recommendation: Remove Botanical Name: Cedrus deodora Health: Poor

Tree B – This large Cedar has lost several large limbs in the past causing the tree to have less than 80% of the foliage on one side causing the tree to be severely unbalance. This tree also lies in the footprint of the new construction. Removal is recommended. (See attached photo)

C. Tree Species: Ash Circumference: 160" Recommendation: Remove Botanical Name: Fraxinus angustifolia Health: Good

Tree C – This tree is a volunteer growing against the fence and causing damage to the fence in addition it is lifting the sidewalk. Half of the root zone lies within the footprint of the new home and will be damaged during the construction process. Removal is recommended. (See attached photo)

I hope that these observations and recommendations aid in the decisions required to address the issues surrounding these trees.
