# Final "Sequencing" Is Determined When a Final Map Is Selected.

- Each draft map has been published with a proposed election year for each district ("sequencing" or "sequence of elections") assigned by the author of the map, or, if not, assigned by random selection.
- The City Council has authority to assign the final sequence of elections to the map it chooses for the November 2020 elections, even if the final sequence differs from that proposed by the author of the map.
- This presentation concerns applicable legal principles and, once legal principles are observed, typical practices in determining sequencing.
- The final sequence of elections will be specific to the selected map.

# Determining Election Year for Districts: 2020 or 2022

- Authority of the City Council: Calif. Const. art. IX, § 5(b)
  - "(b) It shall be competent in all city charters to provide, in addition to those provisions allowable by this Constitution, and by the laws of the State for: ... (3) conduct of city elections and (4) plenary authority is hereby granted, subject only to the restrictions of this article, to provide therein or by amendment thereto, the manner in which, the method by which, the times at which, and the terms for which the several municipal officers and employees whose compensation is paid by the city shall be elected or appointed, ..."

## Determining Election Year for Districts: 2020 or 2022

- Elec. Code § 10010 & CVRA
- "(b) In determining the *final sequence* of the district elections ..., the governing body shall give *special consideration to the purposes of the California Voting Rights Act* of 2001, and *it shall take into account the preferences expressed by members of the districts.*"
- The CVRA provides protection from dilution of the right to vote of Protected Classes by at-large elections in the presence of legally significant racially polarized voting & authorizes "appropriate remedies", "tailored to remedy the violation", which can go beyond the establishment of district-based elections.

## Special consideration to the "purposes of the California Voting Rights Act" - Legislative History

 Support voter "turn-out" of Protected Classes by scheduling elections in districts intended to address an alleged CVRA violation ("CVRA remedial district(s)", herein) in the Presidential election year.

"In November of 2015, the Anaheim City Council scheduled the elections for the two Latino plurality districts for 2016, but scheduled the elections for the only Latino majority district for 2018. The scheduling of the only Latino majority district in a midterm election year could have the effect of putting the elections for a district whose population consists of a majority of a protected class during a cycle in which turnout is traditionally decreased." (Assembly Floor Analysis, Concurrence In Senate Amendments, AB 350 (Alejo) As Amended August 17, 2016.)

 Another reasonable interpretation: Provide for the ability of Protected Classes to elect chosen candidates as soon as possible.

## "The City Council shall take into account the preferences expressed by members of the districts"

- Public input on the sequencing of elections must be taken into account.
- When, as in Sunnyvale, the next election is a Presidential election the choice may seem easy, but the public may see matters differently.
- However, public comment may support delaying election in CVRA remedial district for two years, for example, to develop candidates.
- Public comment may support staggering elections in CVRA remedial districts, for example, when there is more than one such district.
- Public comment may support elections in CVRA remedial districts, for example, in which Protected Class voters are already mobilized, as reflected in registration and turnout data, and thus more likely to elect a chosen candidate.

### Comparison of Sequencing Outcome Giving Priority to Different Relevant Considerations for Map 107A

Assuming elections in three districts each election year, and prioritizing different relevant data (described in the top line below), the following table shows sample sequencing for Map 107A for the Presidential Election Years (note, all percentages and counts in the data sheets are estimates with margins of error)

# Determining Election Year for Districts Not Subject to Special CVRA Considerations

- No statutes or ordinances apply City Council has broad discretion.
- General law cities have similar broad discretion:

#### Gov. Code § 34878.

"If a majority of the registered voters of the city, who vote, vote in favor of the ordinance, at the expiration of the terms of office of the members of the legislative body, or as provided by ordinance, members of the legislative body shall be elected by (or from) the districts described, or by or from districts with an elective mayor, and in the manner provided."

# Determining Election Year for Districts Not Subject to Special CVRA Considerations

- Typically, jurisdictions opt for some continuity on the governing body.
  - 1. In all cases, the election schedule must maintain the correct number of members of the City Council with terms staggered as specified in the City Charter.
  - 2. When one current Council Member (or multiple Council Members whose terms expire in the same year) resides in a district, that district would be assigned to that Council Member's election year.
  - 3. If two Council Members with terms expiring in different years reside in a district, the selection of election year for that district could a) take into consideration that the member with the later election year would continue in office, or b) take other factors into consideration, or c) be made by lot.
  - 4. If more than two Council Members whose terms expire in different years reside in a district, the selection of election year could a) be based on the election year of the majority of resident Council Members, or b) take into consideration that the member(s) with the later election year would continue in office, or c) take other factors into consideration, or d) be made by lot.

(Considers expiration of terms; 3 Council Members elected every other year in Presidential or Gubernatorial Election year; multiple Council Members in Districts B & C with different terms)

# Determining Election Year for Districts Not Subject to Special CVRA Considerations

- There are alternatives to considering the expiration of the terms of current Council Members:
  - 1. All districts seats are up for election in 2020, three of which will have a short term.
  - 2. Selection "by lot".
  - 3. Determination focused on other policy considerations, such as providing for an early election in neighborhoods of the City that may not have had a resident elected to the Council in recent years, or providing for a district-based election in all geographic parts of the City each election year.
  - 4. Combination of considerations.

### Hypothetical #3

(Provides for a district-based election in all geographic parts of the City each election year; 3 Council Members elected every other year in Presidential or Gubernatorial Election year)
