Thank you for your response, however, I'm still uncertain of your role, especially in relation to a city process.

You don't use any State policies in your guidance, but you do state that the Sunnyvale Guidelines for Commercial Child Care Centers includes a policy that: "Child care centers should be located more than 500 feet from any automobile service stations." That is incorrect. The section you quote is from the portion of the guidelines relating to Industrial Areas:

Child care centers are allowed in industrial areas only as business-sponsored facilities (where the facility is for the exclusive use of on-site employees.)

3. Child care centers should be located more than 500 feet from any automobile service stations.

There is no policy regarding distance from these uses in commercial areas. The City has no policies prohibiting these uses in commercial areas, in fact, the Neighborhood Commercial zoning district is considered the best option for these uses because it provides a service to the nearby residents.

I appreciate and value your involvement in maintaining safe child care facilities, but I don't see how the referenced site is inconsistent with State or local policies.

Dear Mr. Miner, our department (CDPH) does not issue child care licenses, the California Department of Social Services (DSS) does. Our role is to educate all stakeholders (including agencies, providers and applicants) on these environmental health concerns, as there are no specific state rules or regulation that require the consideration of these issues at child care facilities. It is the lack of these regulations for child care facilities at the federal and state level that prompted ATSDR to write this guidance.

We have worked closely with DSS and CDE to develop the voluntary checklist and other tools, but we cannot enforce their use. Ultimately it is DSS who will determine if a license is issued.

I hope this information is helpful.

Thank you for providing information regarding the proposed child care center at 755 S. Bernardo Ave, in Sunnyvale and for discussing the site with us. As you know, we were contacted by Mr. Allen Yu (copied on this email), who shared his concerns regarding the proposed child care facility.

My section, the Site Assessment Section of the California Department of Public Health (CDPH), is working with a federal public health agency (the Agency for Toxic Substances and Disease Control, ATSDR) that has developed a guidance for the safe siting of child care facilities to protect children and staff from exposure to harmful chemicals: "Choose Safe Places for Early Care and Education"

(https://www.atsdr.cdc.gov/safeplacesforECE/cspece_guidance/index.html). Under a cooperative agreement between CDPH and ATSDR, my section is implementing this guidance in California on a voluntary basis. We have developed a number of tools for city and county planners, applicants for child care licenses, and providers which are available on our website

(https://www.cdph.ca.gov/Programs/CCDPHP/DEODC/EHIB/SAS/Pages/CSP.aspx). We developed these tools in collaboration with the California Department of Social Services (licensing agency) and the California Department of Education. We understand that the need for child care facilities in a community must be balanced with the suitability of the available sites, and that it is difficult to find an "ideal" location in a developed, urban area. However, the health and safety aspects of each site must be carefully considered. Regarding the proposed child care center at 755 S. Bernardo Avenue, I would like to provide the following information for the administrative record and the planning commission's consideration:

- A large gas station and automotive shop is located across the street (at 750 S Bernardo Ave), approximately 100 ft from the proposed facility. The "Guidelines for Commercial Child Care Centers in Sunnyvale" state that "Child care centers should be located more than 500 feet from any automobile service stations".
- In 2005, the Santa Clara Valley Water District/County of Santa Clara closed an investigation of a leaking Underground Storage Tank at this gas station (closure report: https://geotracker.waterboards.ca.gov/regulators/deliverable_documents/9557081460/CLOS_L_2005-12-21.pdf). Note that contamination west of the site (at the proposed child care facility) was not

investigated. The report states that "Residual contamination in soil remains at the site that could pose an unacceptable risk under certain site development activities ... The county and the appropriate planning and building department shall be notified prior to any changes in land use, ...". This information is 15 years old and pertains to the conditions at the gas station. However, the conditions at the proposed child care location are unknown.

- Please consider using our "Voluntary Environmental Checklist for Early Care and Education Facilities" (attached as pdf) during the decision-making process.
- The California Department of Education (CDE) is currently developing criteria for infrastructure grants under Senate Bill 75. These infrastructure grants can be used to retrofit existing licensed child care facilities, and also to address health and safety concerns at child care facilities (including testing and mitigation of hazardous substances). Per information from CDE, licensed child care centers will be prioritized for these grants during the first funding cycle, starting on April 2020.

If there is interest, we would like to offer technical assistance to the City of Sunnyvale, the applicant, and the community, to ensure the health and safety of children and staff. Please let me know if you have any questions.
