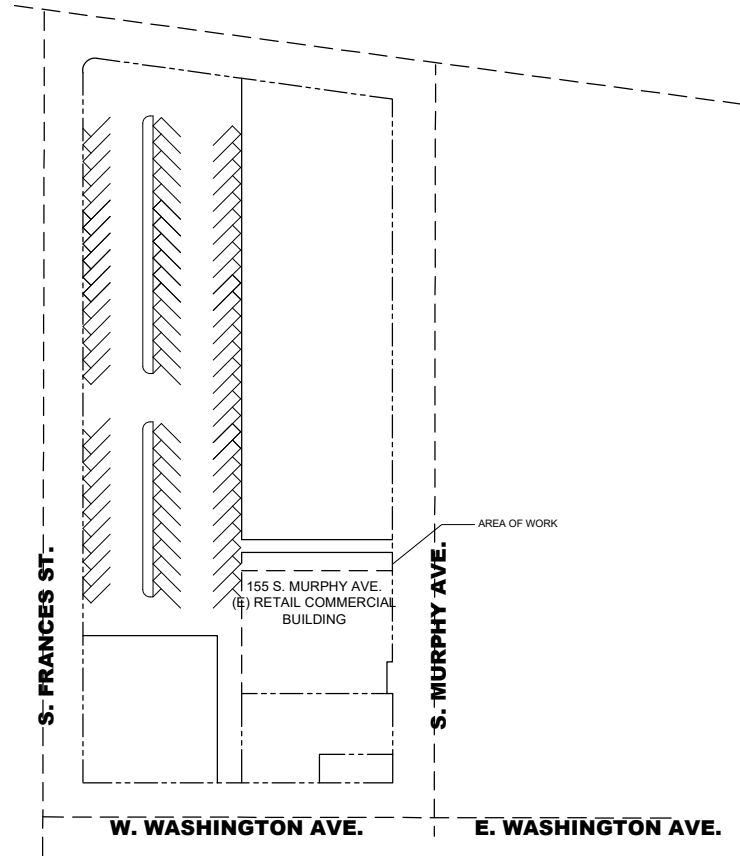

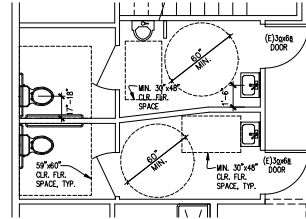

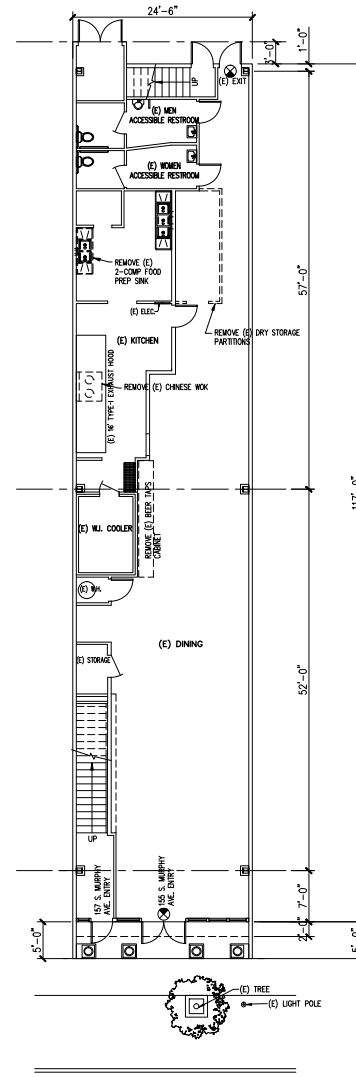

FLOOR PLAN NOTE:

- ALL DIMENSIONS ARE TO FACE OF STUD OR FACE OF CONCRETE, U.N.O.
- ALL NEW KITCHEN EQUIPMENT SHALL BE NSF CERTIFIED.
- INTERIOR NON-BEARING WALLS SHALL BE 2x4 STUDS @ 16" O.C. U.N.O.
- A MINIMUM WIDTH OF 36" OF THE FRONT TRANSACTION STATION COUNTER, WHERE TRANSACTIONS OCCUR BETWEEN SALES EMPLOYEES AND CUSTOMERS, SHALL HAVE A SURFACE BETWEEN 28"-34" ABOVE THE FLOOR.
- INSTALL QUICK DISCONNECT GAS-LINES AT THE EQUIPMENT BENEATH THE HOOD VENTILATION SYSTEM.

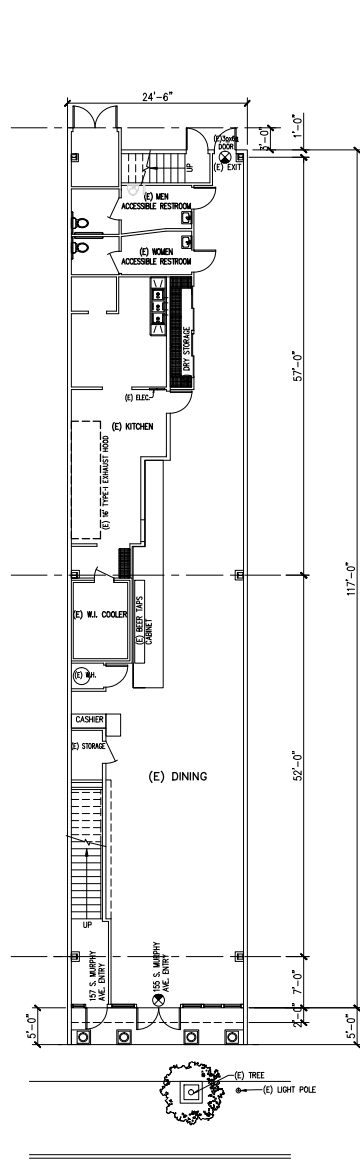

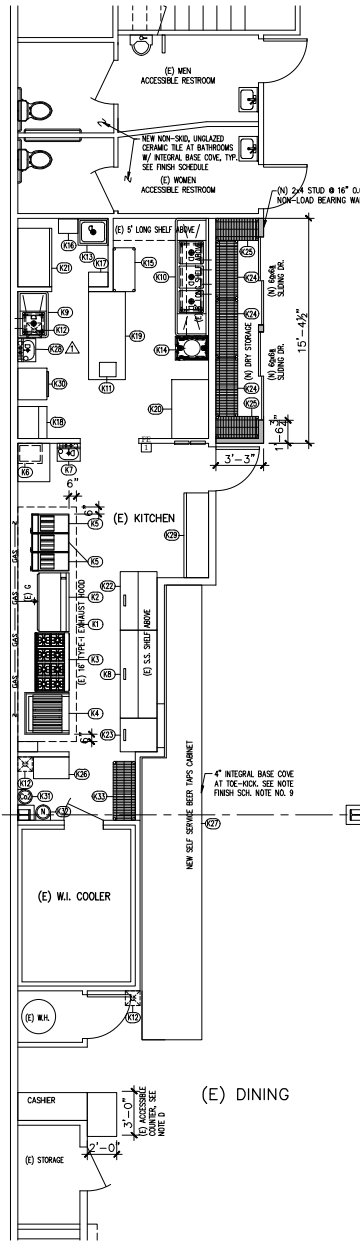

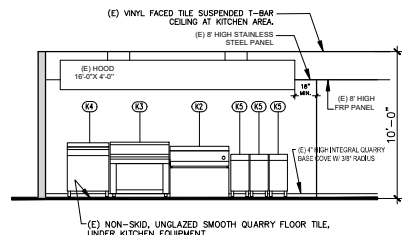
