

Stop Cell Phone Companies From Running Amok in Sunnyvale Communities





Citizens for Safe Wireless Access started this petition to council@ci.sunnyvale.ca.us and 4 others Thanks to the outdated Telecommunications Act of 1996, cities and states are handcuffed from expressing objection to cell towers and other cell infrastructure put up on top of buildings, next to homes, library parking lots, immediately next to highways, on school sites, and other public areas on the basis of health or safety.

***On health and safety, the US's radio frequency (RF) acceptable standards determined by the FCC are almost 100 times hire than that in other major countries - please read the WHO report on the topic . This is also not an area that has been studied extensively, but some initial evidence does suggest that living close to one of these towers (see slide 20), has negative health outcomes. As such, other countries, not overrun by the telecom lobby, are very conservative in RF standards for towers.** Verizon has applied to put up a cell phone antenna/tower in a residential neighborhood in Sunnyvale (near 574 Fort Laramie Drive). The city is soliciting feedback by Wed, Nov 20th at 5 pm. The City of Sunnyvale is currently overrun by cell towers, small cells, etc in residential and public areas (including massive cell sites and even a tower at the library and a local highschool respectively). Please sign the petition NOW to urge the Sunnyvale City Council, City Manager, Attorney and Staff to deny these cell towers and develop a plan that maintains wireless availability without destroying our local values and the aesthetics of our town.

We urge the Sunnyvale City Council and Manager to deny this project and quickly enact strict regulations for the installation, operation and maintenance of wireless telecommunication facilities for the following reasons:

- It will ruin the aesthetics of Sunnyvale. Cell towers will create visual blight and destroy views and detract from the public's enjoyment.
- It will create a dangerous precedent. Other communities that have approved residential cell towers have fallen into this trap and are now fighting 80-foot towers and even 120-foot towers in their communities. Once installed, the wireless carrier has even more legal power to make it 20 feet higher, bulkier, and more of an eyesore. 14 cell towers could metastasize to hundreds or even thousands of more towers - there is no clear limiting principle to stop the spread. While it is AT&T & Verizon today, tomorrow it will be Sprint & T-Mobile, all 26 national carriers putting up huge cell towers in front of houses, schools, or parks. Sunnyvale could turn into a cell tower farm! We already see massive towers on rooftops of buildings on El Camino, and even next to the library (frequented by young children).
- It will tank property values. Studies have determined that homes in the blast radius of radio frequency-emitting cell towers lose 20% or more of their property value. The existence of a cell tower near a home MUST be included in the disclosure packet upon sale.
- It could create a fire hazard. The 2007 Malibu Canyon fire was sparked by wireless equipment attached to a wooden utility pole, just as the AT&T & Verizon plan calls for here in Los Altos. The blaze burned 3,800 acres and destroyed dozens of homes and vehicles.


