REPORT TO SUBCOMMITTEE

SUBJECT

Consideration and Recommendations on: (1) Fiscal Year 2020/21 Community Events and Neighborhood Grant Program Applications, and (2) Changes to Community Events and Neighborhood Grant Program

BACKGROUND

Each year, City Council allocates funding to support community and neighborhood events through the Community Events and Neighborhood Grant Program.

The Community Event and Neighborhood Grant Distribution Subcommittee (Subcommittee) provides the funding recommendations. The Subcommittee consists of three members of the City Council charged with conducting an annual grant review that includes: 1) reviewing grant application process; 2) recommending changes to City Council for approval; 3) reviewing grant applications; and 4) presenting recommended funding levels to City Council for final approval.

The Subcommittee met on January 21, 2020 to review and approve the grant application materials for FY 2020/21. The application period was originally open between February 17 and April 17, 2020 and, based on the timing of COVID-19, extended to June 25, 2020.

At the FY 2019/20 annual budget workshop on May 23, 2019, funding for the programs was doubled. Community Events Grants increased from \$10,500 to \$21,000 and Neighborhood Grants increased from \$6,500 to \$13,000, for a total annual allocation of \$34,000.

In FY 2019/20, Council approved eight Community Events Grants for \$24,000 and twelve Neighborhood Grants for \$10,210 for a total of \$34,210. These events served an estimated 29,000 community members and included, but were not limited to: National Night Out, block parties, summer concert series, movie nights and the Pet Parade.

The purpose of this report is to provide recommendations to update the grant application process and distribution, review the grant applications received and seek direction from the Subcommittee on the recommended funding for each application. The Subcommittee is scheduled to present its recommendations to Council on July 28, 2020.

The City may fund community events through this program.

ENVIRONMENTAL REVIEW

The action being considered does not constitute a "project" within the guidelines of the California Environmental Quality Act ("CEQA") pursuant to CEQA Guidelines section 15378(b)(4) in that is a fiscal activity that does not involve any commitment to any specific project which may result in a potential significant impact on the environment.

DISCUSSION

Proposed Changes to Grant Application Process

Traditionally, the grant timeline process has been based on a fiscal year, from July to June, with applications due in April and funding approved/confirmed in June. With the majority of events happening between June to September, this can lead to some community and neighborhood groups having difficulty planning a successful event while awaiting the outcome of their funding. To address this, staff is recommending that the grant application process be moved to a calendar year, January to December. The grant application process would be held between October 1 and November 15, with the sub-committee meeting in late November or early December and providing recommendations for Council approval in January. With this adjusted timeline, community and neighborhood partners will have enough time to plan their events based on actual funding they will be granted.

Proposed Changes to Neighborhood Funding Cap

Currently, funding for Community Events is \$21,000 and Neighborhood Grants is \$13,000, with no funding cap for Community Events and a \$1,000 cap for Neighborhood Grants. To further support Neighborhood Grants, staff is recommending increasing the Neighborhood Grant funding cap to \$1,500. Increasing the cap will allow Neighborhood Associations to hold either multiple events or larger events each year, increasing the reach and connection within their respective neighborhoods.

FY 2020/21 Grant Application Overview

As of the June 25, 2020 application deadline, thirteen applications were received (six Community Events and seven Neighborhood applications) for a combined funding request of \$34,565 as follows:

Enclosed is a summary of the applications received for FY 2020/21 along with historical data on past allocations (Attachments 1 and 8). Copies of the individual grant applications are also provided as Attachments 2-15. For privacy reasons, personal information of individuals submitting applications and project team members on pages one and five of the Neighborhood Grant applications has been redacted.

The Subcommittee's recommendation for grant distribution is based on the budgeted amount of \$34,000 allocated for the Community Events and Neighborhood Grants Program.

FISCAL IMPACT

Subcommittee recommendations are included in the FY 2020/21 Recommended Budget within the Library and Community Service Department Operating budget. This year, \$34,000 is included for the grant programs.

ALTERNATIVES

- 1. Review the FY 2020/21 grant applications for Community Event and Neighborhood Grant programs and approve funding levels to be submitted to City Council for final action; and approve program process changes including changing the timeline from a fiscal to calendar year, and increasing the funding cap for Neighborhood Grants to \$1,500.
- 2. Take other action as determined by the Subcommittee.

RECOMMENDATION

Alternative 1: Review the FY 2020/21 grant applications for Community Event and Neighborhood Grant programs and approve funding levels to be submitted to City Council for final action; and approve program process changes including changing the timeline from a fiscal to calendar year, and increasing the funding cap for Neighborhood Grants to \$1500.

For this fiscal year, staff recommends approving all grant applications with the funding amounts outlined in the table above. The total grant distribution amount would be \$34,000.

Staff also recommends that the Community Event and Neighborhood Grant Distribution Subcommittee recommend that Council approve the following changes to these grant programs: 1) updating the application process to change the timeline from fiscal to calendar year; 2) increasing the Neighborhood Grant funding cap to \$1,500.
