SCOPE OF THE STUDY

What precipitated this study?

At the August 28, 2018 City Council meeting, Mayor Hendricks sponsored a study issue to consider creating an eruv within Sunnyvale after receiving a request by the South Peninsula Hebrew School.

An eruv is a Jewish term for a system that integrates a number of private and public domains and creates a larger technical private domain within the context of Jewish law. Under Jewish law, it is forbidden to carry certain items, regardless of their weight, size or purpose, from a private domain into a public domain during the certain Jewish holidays, such as the Sabbath. The creation of an eruv permits observant individuals to carry these items within the eruv as an extension of the private domain and thereby allows for greater community mobility during these holidays.

An eruv can be comprised of a series of pre-existing structures (walls, fences, electrical poles and wires) and/or minor structures created expressly for the eruv, often a wire mounted on poles, to minimize disruption to the surrounding community. Staff anticipates that as part of the study the South Peninsula Hebrew School would need to outline the eruv boundaries and physical characteristics of any new elements needed to complete the eruv.

What are the key elements of the study?

This study will consider the feasibility and legality of establishing an eruv in Sunnyvale and may:

- Identify issues and concerns relating to public safety;
- Determine appropriate reviewing body and process for an eruv application;
- Create design guidelines and criteria in the review of an eruv;
- Identify maintenance needs and responsibilities that need to be addressed with the eruv
