# The challenges with single-use plastics and their alternatives:

#### **Single-Use Plastics**

- Made from non-renewable resource
- Production is harmful to environment and contributes to GHG emissions
- Have a very short lifespan
- Cannot be easily recycled
- End up as litter

## Alternatives (bio plastic and fiber/paper)

- Production results in pollutants due to fertilizer/pesticide & chemical processing
- PFAS and plastic coating added to make them moisture resistant
- Not recyclable or compostable in Sunnyvale programs
- End up as litter

## Local and regional actions



- Berkeley, Santa Cruz, San Mateo County passed/implemented SUP ordinances
- Palo Alto is only SCC city to implement ordinance
- Santa Clara County TAC sub-committee developed model ordinance
- Regional/state move to require "optin" option for take-out/delivery accessory items
- Promising State packaging reduction bills failed to pass in 2020 but is resurfacing again in 2021

## Santa Clara County Model Ordinance

Phase 1

- Foodware must be compostable
- "Opt In" for takeout accessory items
- Accessory items upon request only

#### Phase 2

- \$0.25 charge on cups
- Reusables for on-site dining
- Dishwashing capacity



#### Phase 3

• Reusable cups at events

## COVID IMPACTS

- Take-out and delivery has increased 200-300 percent
- Increased disposables used for take-out/delivery and some outdoor dining
- Reusable cups not currently allowed
- Many jurisdictions not enforcing SUP bans

## **RTC Recommendation**

- Alt. 2: Direct staff to develop an ordinance to be implemented and phased in over three years to reduce the impacts of singleuse plastic foodware and condiment containers, and return for City Council approval of the Ordinance after appropriate CEQA review, with a targeted Ordinance adoption date of September 2021:
  - Phase 1 An opt-in requirement for foodware and condiment containers for online and take-out ordering from food service delivery vendors and restaurants, to take effect in September 2021
  - Phase 2 Require food service businesses to provide customers with single-use plastic foodware and condiment containers only upon request, to take effect in June 2023

Additionally, direct staff to return to Council in late 2023 with a proposal that evaluates further recommendations for the program.

### **Outreach Strategy**

- "Opt-in" outreach to start 3-4 months prior to ordinance implementation
- "Request only" outreach to start 1 year in advance during SB 1383 site visits
