

INVESTMENT PORTFOLIO BALANCE BY FUND/S SECOND QUARTER ENDING JUNE 30, 2021




INVESTMENT PORTFOLIO PORTFOLIO BALANCE TREND




SECTOR ALLOCATION


MATURITY DISTRIBUTION

Pooled Money Investment Account Monthly Portfolio Composition (1) 06/30/21 \$193.3 billion


