Brandt Burns, Director of Facilities and Operations, Sunnyvale School District, communicated the need to plan for new schools as a Tier 1 priority.

Kenneth Javier-Rosales, SV@Home, spoke about adding further affordable housing development incentives to the community benefits.

Perry Harir, Miramar Capital, communicated points to consider to incentivize developers and their building projects.

David Harty, Ellis Partners spoke in support of the community benefits goals and offered concerns about certain infrastructure plans and limitations developments may face.

Ray Hashimoto, HMH Engineers, offered alterative insights to consider when developing the policies and restrictions for potential projects.
