City Manager Kent Steffens provided the staff report and slide presentation. Consultant Todd Kohli, Principal with SmithGroup JJR group provided information and a slide presentation detailing the Master Plan Full Vision.

Mei-Ling Stefan spoke in opposition to approval of the EIR, and in opposition to Phase 2 to move the Public Safety building. She recommending elimination of Phase 3.

Jim Davis spoke in support of removal of the 505 West Olive buildings, and recommended using surface parking at that location rather than the proposed underground parking. He spoke in opposition to moving the Public Safety building.

Richard Mehlinger spoke in support of the design, enhancement to amenities, and the improvements in community meeting spaces. He also supported the concepts of promoting accessibility and bike lanes, with priorities given to human beings.

Zachary Kaufman spoke regarding unfunded liabilities and budget strategies.

Margaret Lawson spoke in support of the building and plan design.

Director of Community Development Trudi Ryan provided the staff report.

Public Hearing opened at 9:50 p.m.

Applicant/Appellant Nirmal Sharma provided information and slide presentation regarding the project.

Mary Sullivan stated the bulk, scale and height of the project does not fit in the neighborhood and requested support of the Planning Commission's decision.

Sherri Tafel stated the proposed house is out of scale with the neighborhood and stated the open space and lot coverage are needed for recharging the water table and avoid flooding from runoff.

Maria Hamilton spoke regarding privacy and design concerns by a neighbor. She urged the Council to look at the plan in the context of an existing, established neighborhood and keep the design consistent with the neighborhood.

Sue Harrison, member of the Planning Commission speaking for herself, spoke in support of ADUs and expressed concern regarding the relative bulk and height of the proposal.

Irene Conley expressed concerns stating the proposed project does not fit in the neighborhood and concerns about the setbacks and quality of life.

Henry Alexander III spoke regarding privacy concerns between neighbors, height restrictions and safety considerations with the setbacks.

Eric (no last name provided) expressed concerns regarding the size of the project, proposed FAR, proposed property zoning for R-1 low-density, proposed height, and requested consideration of the neighborhood.

Applicant/Appellant Nirmal Sharma responded to comments regarding setbacks, lot coverage, ADU, and height.
