Superintendent of Community Services, Damon Sparacino noted that there was not a staff report, other than what was submitted in the packet. Superintendent Sparacino asked the Members to consider moving the time frame of grants from fiscal year to calendar year for aligning purposes and shared the year to date recap of FY 2019/20 grant reimbursements.

The Members discussed the realignment and the wording on the application related to event fundraisers.

Director of Library and Community Services, Cherise Brandell and Superintendent Sparacino noted that they would look at the wording, run it by legal and update (if possible) the application to reflect the updated fundraiser language related to third party event parties.
