REPORT TO CITY COUNCIL

SUBJECT

Selection of Name for New City Park at the Vale Development

SUMMARY OF COMMISSION ACTION

The Parks and Recreation Commission (PRC) considered this item on June 13, 2018.

The PRC voted to submit three names for consideration and selection by the City Council. The vote was 3-1 with Commissioner Pasque dissenting and Commissioner Alexander III absent. The PRC also voted to prioritize the park names in the following priority order: a) Loren Wiser Memorial Park; b) Jeanine Stanek Park; and, c) Richard Milkovich Park. The vote was 3-0, with Commissioner Pasqua abstaining and Commissioner Alexander III absent. See Attachment 5 - Excerpt of Draft Parks and Recreation Commission summary minutes of June 13, 2018.
